## NATIONAL RETAIL PROPERTIES, INC. ANNOUNCES OFFERING OF DEPOSITARY SHARES REPRESENTING SERIES E CUMULATIVE REDEEMABLE PREFERRED STOCK

**Orlando, Florida, May 22, 2013** - National Retail Properties, Inc. (NYSE: NNN) (the "Company") today announced that it has commenced an underwritten public offering of depositary shares, each representing a 1/100<sup>th</sup> interest in a share of its newly designated Series E Cumulative Redeemable Preferred Stock. As part of the offering, the Company also expects to grant the underwriters a 30-day option to purchase an additional 15 percent of the depositary shares initially offered. The Company intends to apply to list the depositary shares on the New York Stock Exchange under the symbol "NNNPRE". If its application is approved, the Company expects trading of the depositary shares on the New York Stock Exchange to commence within the 30-day period after the initial delivery of the depositary shares.

Citigroup Global Markets Inc., Merrill Lynch, Pierce, Fenner & Smith Incorporated, Wells Fargo Securities, LLC and Raymond James & Associates, Inc. will act as joint book-running managers for the offering. The Company intends to use the net proceeds from the offering for general corporate purposes, which may include funding future property acquisitions.

This offering is being made pursuant to an effective shelf registration statement and prospectus and related prospectus supplement to be filed with the Securities and Exchange Commission.
